

**INTERIM 2013 IMPORT STATISTICS RELATING TO COMPETITIVE NEEDS LIMITATIONS FOR THE
GENERALIZED SYSTEM OF PREFERENCES**

Based on January-August 2013 trade data

As stated in the Federal Register notice ([78 Fed. Reg. 45596](http://www.federalregister.gov/?date=2013-07-29)) published on July 29, 2013, USTR is prepared to receive petitions requesting waivers of competitive need limitations (CNLs) for the Generalized System of Preferences (GSP). The deadline for submission of such petitions has been extended to 5 p.m. EST on Friday, December 20, 2013. Notice of the deadline extension will be published in the *Federal Register* on November 22, 2013. The table below provides information on products that, based on eight-month (January-August 2013) trade data, may exceed CNLs for 2013. This information is provided as a courtesy for informational purposes only. Regardless of whether or not an article is included on this list, all determinations and decisions regarding CNLs will be based on full calendar-year 2013 import data with respect to each GSP-eligible article. Interested parties are strongly encouraged to research the trade statistics for themselves. The U.S. International Trade Commission's "DataWeb" website is a useful source for this information.
